Training Description:

This workshop will use a mix of didactic, audience response, small group, dyad and personal introspection exercises with the goal of pushing staff and managers of substance abuse treatment programs/systems to identify personal, programmatic, systemic and policy factors that are affecting the effectiveness of services. The workshop presents evidence-based strategies for addressing those challenges. Each learner will craft an action plan for initiating personal, programmatic, systemic and advocacy interventions in their professional setting as appropriate to their role.

Upon completion of this workshop, learners will be able to:

- 1. Describe history and meaning of the term African-American.
- 2. List three types of cultural variations among individuals described as African American.
- 3. Understand the impact of historical experiences of African-Americans with the medical community on current retention and outcomes.
- 4. List 3 ways implicit bias can affect treatment retention among African-Americans.
- 5. Describe four evidence-based individual, programmatic, organizational, advocacy interventions designed to improve retention and clinical outcomes among African-American individuals seeking substance abuse treatment.
