2 Programs: **BIRTH TO 8YO**, and **8 TO 18YO**

### SERVICE AUTHORIZATION

The Child/Youth FSP WRAP program is available in two (2) programs for Birth to 8yo, and 8 to 18 year olds through the Alameda County BHCS MHSA Full Service Partnership. To be eligible, Children/Youth must meet SED or Moderate-Severe Criteria, and meet the indicators/criteria indicated on the referral form, and have Full Scope Medi-Cal, or be Indigent or Undocumented. All referrals to the FSP Wrap Programs Services will be reviewed and authorized by the Alameda County BHCS ACCESS Program.

### WHAT IS WRAPAROUND?

Wraparound is an intensive, holistic method of engaging with children, youth and families with complex needs through a defined model of care. Wraparound is not treatment *per se*, Wraparound is an intensive, individualized care planning and management process aimed at achieving positive outcomes through structured, creative and individualized team planning. Perspectives of the family, including the child and youth are given priority importance during all phases and activities of Wraparound. Over the course engagement, the Wraparound programs work to develop a team of natural supports to be available to the youth and family after the Wraparound services are no longer in place. Wraparound takes place in 4 Phases:

**Phase 1** – Engagement and Team Preparation    **Phase 3** – Implementation  
**Phase 2** – Initial Plan Development                **Phase 4** - Transition

### WHAT SERVICES DOES THE FSP WRAP TEAM PROVIDE AND WHAT IS THE COMPOSITION OF THE TEAM?

The Wrap Team provides Care Coordination, Case Management and Mental Health Rehabilitation Services to youth and their families through a family centered, child and family team approach. The Wrap Team will actively coordinate and collaborate with all other BHCS providers working with the youth and family. The Wrap Teams are composed of: Clinicians, Family Partner, Peer Specialist or Support Counselor and a Medication Provider.
