Training Description:

Latinx communities have rich histories and strengths that foster resilience and possibilities for flourishing. Latinx communities in Alameda County are also grappling with rapid changes fueled by economic and political forces. We know that the needs of people and communities vary based on their own identities and experiences, as well as how systems and institutions perceive and relate to them.

During this training, we will work with two concepts that can help us become aware of the complexities faced by individuals and their communities: *Intersectionality* and *Layering of Trauma*. By applying an *intersectional* lens, we can better understand ways in which a Latinx person's needs and the solutions may be identified.

Upon completion of this workshop, learners will be able to:

- 1. Articulate an understanding of systemic inequities and the particular ways they create challenges for Latinx communities, with attention to data on Latinx communities in Alameda County.
- 2. Recognize and identify strategies to address systemic barriers experienced by Latinx communities.
- 3. Develop an understanding of cultural norms and how they may inform and impede their ability to provide the best service communities need.
- 4. Cultivate and/or improve wellness skills, strategies, and concepts (such as Posttraumatic Growth) to help prevent, assess, and address secondary and vicarious traumas.
