This training will help participants address some of the common misconceptions about culture, and take a close look at how personal and organizational culture can drive our interactions with beneficiaries, and impact their treatment outcomes.

By the end of this training, participants will have increased their capacity to:

- 1. List at least three causes for under-representation and misdiagnosis of Native Americans in Behavioral Health
- 2. Name at least three barriers to success in working with Native Americans
- Describe at least 5 elements of 'deep culture' that are distinct to Indigenous communities that impact their understanding and perceptions of behavioral health
- 4. Identify at least 2 additional resource (curriculum, partners, etc.) that can serve as resources
- 5. Assess one's own cultural perspective and capacity to provide culturally informed treatment
