Participants will learn more about the relationship between smoking and complications from exposure to the coronavirus. Participants will learn how to tailor key health messages as it relates to COVID-19 risk to help motivate and support tobacco use quit attempts among high-risk populations.

Who Should Attend: Clinical Staff of substance abuse, mental health and primary care providers, Health Educators, Community Cessation Facilitators, Case Managers, Home Health Care Workers, Nurses and other healthcare providers.

Learning Objectives: at the end of the training, participants will be able to:

- 1. Share two key messages with patients or clients on how tobacco use can put them at a higher risk of COVID-19 infection and complications.
- 2. Name at least two treatment options and services that can help with tobacco treatment with clients/patients.
- 3. Create a quit plan with a client over the course of a 15-20 minute one-on-one counseling session
- 4. Discuss the tobacco-related risks associated with tobacco use under COVID, and treatment strategies for clients sheltering in place
