Training Description:

An interactive workshop to address the most salient factors that shape the mental health and healing of diverse Latinx people and communities.

This workshop presents a culturally responsive practice-based, community-defined model that can ultimately be used to inform and/or improve clinical SUD/MH guidelines and practices for mental health and SUD professionals working within Latinx communities. - 4. Participants will be able to explore 2 culturally appropriate community-based methods to assist their patients with MH/ SUD
