Codes and Rules

The following required changes below applies to Providers that have their own Electronic Health Record (EHR) system. For Providers that use the County's Billing and EHR systems (InSyst and Clinician's Gateway), those systems will be updated with these changes.

Changes include:

- Required implementation date of January 1, 2021;
- Deletion of CPT Code 99201;
- Addition of the add-on prolonged service Code 544-99417 (15 minutes);
- Duration time-frame changes to CPT[®] Codes 99202 99205 and 99211 99215 (see below and attached 2021 CPT E/M requirements).
