**SUBJECT:** CHANGES IN FORENSIC OUTPATIENT AND FSP PROGRAM OVERSIGHT

This communication is intended to alert you to changes in both forensic outpatient and FSP program oversight within the Adult/Older Adult System of Care. Alameda County Behavioral Health (ACBH) is in the process of aligning forensic outpatient programs under the newly created Forensic, Diversion and Re-Entry System of Care, and is also moving all Full-Service Partnership (FSP) programs under new ACBH leadership.

Please note that although several of the forensic programs began their transition to the Forensic, Diversion and Re-Entry System of Care in July of this year, full transition will be in effect by the dates listed below.

In the near future you will receive information from your operational lead regarding upcoming meetings, one of which will include the current Quarterly FSP meeting that you already attend.
