**Description:** The worldwide COVID-19 Pandemic coupled with stay at home orders, increased demands on workers to care for family members, economic hardships, national political tensions and more, has pushed workers and those they serve to struggle how to navigate the rapid-fire changes to their daily lives. The same stressors and demands are also being experienced by the consumers and their families affecting their participation in their behavioral health treatment. This course will explore the impact of events on consumers/clients and the clinical practice approaches needed to support consumer/client treatment goals. The course content is applicable and useful for clinical, consumer, administrative, managerial, program and support staff.

- 2. Name the 6 stages of grief and loss and how they are reflected in behaviors and the ability to engage in services
- 3. Identify 3-5 core values that can support navigating the post pandemic world and the economic, societal, and health challenges that staff and the consumers/clients being served are experiencing.
- 4. Prepare for difficult conversations with at least one teammate, service provider and consumer/client health systems regarding the impact of the COVID-19 pandemic and 2020/21 social upheavals on mental health and substance use disorder conditions.
