Target Audience: ACBHCS Providers only. All organizations who bill through INSYST and self-authorize through INSYST. Note: Organizations that are new to billing Medi-Cal or who have received new contracts or started new programs (including organizations that take over an existing contract from another agency) are required to attend county run CQRT meetings and will be provided with a special CQRT training during the first meeting.

Description: Addresses the CQRT process, self-authorization, using (new and improved) CQRT forms, reducing risk of audit disallowances.

Trainers: Jeffrey Sammis, PsyD, Clinical Review Specialist Supervisor of Alameda County Behavioral Health Care Services. Dr. Jeffrey Sammis has been in the mental health field since 2001 and has provided clinical services to California Medi-Cal beneficiaries since 2005.
