

BHCS CONTRACT SUBMITTAL

In response to Contractor requests to provide timelier contract renewals, BHCS' Network Office has been working to provide Contractors with the documents needed to submit contract renewal packages much earlier than in previous years. BHCS released the vast majority of contract renewal packages for FY 12/13 by June 7, 2012. To promote process improvement, BHCS' Network Office has been collecting data on the timeliness of contract renewal submissions.

For Contractors who are not listed below, BHCS requests your cooperation in providing requested contract renewal documents as soon as possible, but no later than August 10, 2012 directly to contracts@acbhcs.org.

Late submittal of documents negatively impacts and interrupts other processes, such as Year-End Cost Reports, and contract amendments. BHCS plans to update this list weekly as a reminder to please submit outstanding contract renewal documents as soon as possible.

As of July 27, 2012, seventeen (17%) of MENTAL HEALTH Contractors submitted complete contract renewal documents.
