Subject: BHSA Transition: SMHS Documentation Training and Resources

Purpose

This memo is to notify providers who plan to transition to becoming Specialty Mental Health Service (SMHS) Early Intervention providers of upcoming documentation training and other resources to assist with this transition.

Background

Due to the Mental Health Services Act (MHSA) transition to Behavioral Health Services Act (BHSA) effective July 1, 2026, Alameda County Behavioral Health Department (ACBHD) is providing an opt-in opportunity for Early Intervention (EI) Providers to transition to becoming Specialty Mental Health Service EI (SMHS EI) Providers. This will require compliance with all SMHS Medi-Cal regulations.

ACBHD Training: SMHS Documentation Requirements

ACBHD is offering a series of training modules to assist providers who have chosen to opt-in to this transition. The next training topic, *SMHS Documentation Requirements* is in two parts, each followed by a live Question/Answer session. Topics include the following:

- Screening and Transition Tools

- Plan Development
