### RESPONSES TO BIDDERS QUESTIONS

#### General

- Q1) Is the Faith and Spirituality Based Mental Illness Stigma for African and African Americans an ongoing funding source (year to year)?  
**A1) ACBH anticipates that the contract funding will be ongoing, however, renewal of the awarded contract shall be contingent on the availability of funds, awarded Contractor's performance, and continued prioritization of the activities and priority populations as defined and determined by ACBH, per section I.A on page 3 of the RFP.**
- Q2) Every year would the monies increase or stay the same?  
**A2) It is anticipated to be the same. See response to Q1 for more information.**
- Q3) If we have a fiscal sponsor that is a 501c3, are we eligible to apply?  
**A3) Bidders must meet Bidder Minimum Qualifications in section I.D. on page 6 to be eligible to participate under this competitive bidding process. Per the Minimum Qualifications, the lead agency/Bidder must be recognized as a 501(c)(3) in order to submit a proposal. The lead Bidder may subcontract and/or partner with other agencies to deliver program services.**
- Q4) Is the PEERS proposal available for public viewing?  
**A4) Yes. On July 9, 2019, the Board of Supervisors approved the contract award for PEERS to deliver the Interfaith Stigma Reduction following RFP #18-06. It is GSA's policy to make the successful proposal, after the negotiations and award of the contract, be open to public inspection. Bidders interested in viewing PEERS proposal may reach out to the RFP lead to schedule a time to view the bid.**

#### Priority Population

- Q5) Why was African included?  
**A5) ACBH identified the need to expand the priority population to include both individuals identifying as of African descent and/or African American. Data suggest that stigma is prevalent in most communities affected by mental health issues and of particular concern for African Americans. ACBH attempted to examine the number of communities of faith in Alameda County and located several documents listing more than 300 communities, many listed by zip code (included in Appendix**

**I). In West Oakland alone, we identified the names of over 60 African American churches. These numbers far surpassed the targeted number in the previous RFP.**

Q6) Does the County have data/ demographic available?

### **Program Services**

Q7) On p.6 what is an example of other faith or spiritual community?

**A7) Per section I.C. on page 5, faith and spiritual/ healing communities shall include a diversity of ongoing traditional and non-traditional religious practices, non-religious, spiritual congregations, and healing communities throughout Alameda County serving the priority populations.**
