## 1. Onboarding Status Report

Staff Certifications are now flowing freely from www.CANStraining.com into Objective Arts (OA) without incident this past week. Thank you LearnerNation for the fix!

To date, 12 organizations have successfully attested and have been assigned Go-Live dates. Six have already gone "Live" plus another three on Monday, and several during the remaining weeks of February.

## 2. Attestation Deadline is $\mathbf{2 / 2 9 / 1 6}$

The Attestation Deadline for all Organizations (Cohorts 1-4) is Monday, 2/29/16, 5pm

## 3. OA Readiness Attestation Simplified

Before you submit your Attestation, follow these steps:

1. Ensure that all your clinicians are in the OA Training site
2. Ensure that all of your clients are in the OA Training site with the correctly assigned RU and clinician
3. Ensure that all certifications are coming through in OA Training.

Once you have completed those steps, you can request for access to the OA Production site, to update roles and permissions of your staff. After that, you are ready to attest.

## 6. Guidelines for Using the New CANS and ANSA-T Versions:

## Multiple Caregivers

New versions of the CANS and ANSA-T offer the option for rating multiple caregivers. There is now the option of providing the caregiver's name and listing their relationship to the child/youth. If you don't find the correct relationship to describe the caregiver, choose "Other."

## Items with an "N/A" option

If entering an older version into the Objective Arts system and an "N/A" option is no longer available, please select " 0 " for that item.

## The numerical order of items

The order of items (and the numbers corresponding to them) may have changed in recent versions. The latest CANS and ANSA-T versions should now accurately match up with paper and electronic versions of the measure. However, if transferring older versions into Objective Arts, please be mindful that items

may have shifted during takeoff.

## Signature lines

Clinicians requiring approval on forms now have a place for their supervisor's approval on the paper version of the CANS Rating Sheets. For older versions without a signature line, agencies should ensure that clinicians and supervisors have signed (where applicable).
