## The Self-Assessment for Modification of Anti-Racism Tool (SMART): Addressing Structural Racism in Community Mental Health

**Description:** This training will introduce participants to the Self-Assessment for Modification of Anti-Racism Tool (SMART), an innovative self-directed quality improvement tool developed by the American Association for Community Psychiatry (AAPC) to assist community mental health organizations in addressing structural racism. The presenters will describe the process by which SMART was developed, including its grounding in input from community mental health providers and existing health inequity frameworks. The domains and items of SMART as well as its application process will be outlined. Presenters will also provide lessons from on-the-ground applications of SMART's process and principles in Philadelphia's public mental health system.

### **Learning Objectives – After this training, participants will be able to:**

- 1) Describe the rationale and process for the development of the SMART, including its connection with existing health inequity frameworks;
- 2) Understand how to implement the SMART within an organizational setting;
- 3) Learn how to use data to facilitate dialogue and structure attainable organizational change goals;
- 4) Examine what you can do to champion a culture of ongoing, data-informed change within your organization.
