Target Audience: Staff of all departments of Alameda County's HCSA agency, <u>and</u> their contracted CBO staff, including: Office of Agency Director, Behavioral Health, Public Health, and Environmental Health. Direct service County and contracted providers are especially encouraged to attend, as well as program managers and staff who work with PHI.

Trainers: Linda J. Garrett, JD has been providing healthcare compliance consultation to healthcare facilities and providers for over 35 years. Ms. Garrett has practiced as a medical malpractice defense attorney in San Francisco California. She trains providers and administrative staff on a variety of medical/legal topics including informed consent, mandated reporting, involuntary mental health treatment, patients' rights and state and federal confidentiality laws. **Andrew Garrett, JD** is an attorney who works directly with healthcare providers, helping them navigate the laws of their profession. His practice is concentrated on issues of confidentiality, behavioral healthcare, correctional healthcare and mandated reporting.

Description: This 6-hour web-based workshop will review new legislation that affects healthcare providers in California, or their patients/clients. It will also alert participants to changes in the law that directly impacts involuntary "hold" patients' Due Process rights when they have not been released from a hold after 72 hours. Finally, we will look at the perils of social media for healthcare providers when anything work-related is posted, and best practices for disengaging with difficult patients.

Learning Objectives – at the end of the training, participants will be able to:

- Articulate two new screening requirements: suicidality in certain patients, and fentanyl use when urine drug screenings are performed; in general and in acute hospitals.
- Describe two new provisions related to transgender, gender diverse and intersex (TGI) training and directory requirements.
- 3. List two requirements for written notice to patients about the Open Payments data base;
- 4. Describe two changes in the LPS Act related to involuntary patients' due process rights after a hold has been "written";
- 5. Articulate new laws that protect California providers, and shield patient records, including information about abortion or gender-affirming care, from civil or criminal proceedings conducted by foreign jurisdictions (i.e. AB 2275 and AB 2242);
- 6. Describe best practices for disengaging from difficult patients while assuring access to care.
