**Description:** This two-day training will enrich participants' understanding of the major mental health conditions and substance use concerns facing older adults, as well as the importance of promoting mental wellness and resilience. Attention will be paid to the importance of screening, assessment, and evidence-based interventions, emphasizing integrated care. The group will learn about self-care and hear from a speaker with lived experience.

#### Learning Objectives – at the end of the training, participants will be able to:

- 1. Learn how to interpret results of SLUMS and Mini-cog, will be able to name three outpatient services available for OA.
- 2. Define polypharmacy and learn three ways anti-anxiety medications impact older adults.
- 3. Name two reports that the Empowered Aging Agency is expected to investigate and will be able to name three reasons the role of the ombudsman is critical to the care and safety of older adults in long term care facilities.
- 4. Name three risk factors and warning signs of Alzheimer's Disease and Dementia and be able to identify three supports for caregivers.
- 5. Name two reasons why cultural competence is important for MH providers and will be able to name the two work units within the Office of Health Equity.
- 6. Name three types of intersections that may impact an older adult's experience receiving mental health treatment and name two reasons why treating the whole older adult is critical to successful care.
- 7. Learn four ways to access SUD services within Alameda County, will learn SAMHSA's 8 dimensions of wellness for older adults with SMI and SUD, and identify the six specific increased risk areas for older adults who misuse alcohol.
- 8. Name three crisis services in Alameda County, name the locations of the crisis offices in Alameda County, and name three examples of the effective Crisis Services.
