About the Course

The goal of this training is for participants to distinguish among some of the most commonly used and widely researched trauma-informed and trauma-focused interventions in working with clients who present with acute, chronic, or complex trauma. The training will primarily expand and strengthen the participants' clinical skills on telehealth adaptations of trauma-focused and trauma-informed interventions in working with clients. The training will also increase the participants' competencies in integrating telehealth adaptations of some culturally-adapted trauma-focused interventions in their clinical work with Black, Indigenous, and People of Color (BIPOC) clients. Finally, the training will culminate in the participants' development of a tentative plan on how to implement trauma-focused telehealth tools in their individual clinical practice and/or behavioral health programs.

Full time of training: from 9:00 AM - 12:10 PM, 3 hours and 10 min.

Instructional time: 3 hours

Non-instructional time: 10 min

There will be one 10 minute break, during which continuing education credit is not accrued.

Educational Objectives

- Identify and describe at least two clinical considerations when using telehealth for working with clients exposed to trauma and/or experiencing ongoing trauma.
- Appraise the applicability of at least two core elements of trauma-focused interventions in engaging behavioral health clients in telehealth.
- Illustrate at least two ways of culturally-adapting trauma-focused interventions when working with BIPOC clients.
- Construct and organize tentative plan with at least two action steps on how to use telehealth tools to help clients exposed to and/or experiencing trauma.

About the Presenter

Ritchie Rubio Ph.D. in Clinical Psychology:

As current Director of Practice Improvement and Analytics at the San Francisco Department of Public Health – Behavioral Health Services, I strengthen our system's efforts to integrate trauma-focused and culturally-responsive practices in the use of telehealth with primarily BIPOC clients. During the past 2 years, I have been developing curriculums and providing state- and nation-wide trainings on telehealth adaptations of clinical practices specifically trauma-informed and trauma-focused interventions. I am also an adjunct professor (formerly associate professor) at the counseling psychology programs of the University of San Francisco, Pepperdine University, and The Wright Institute in Berkeley. Relevant to this training, I have taught courses such as Trauma and Crisis Counseling; and Trauma-Informed care.
