Course Description:

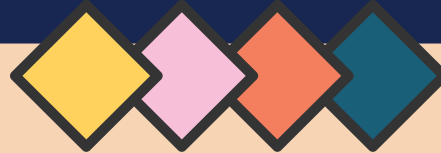
This training will provide participants with foundational knowledge of health equity issues facing the LGBTQIA+ community, focusing on the intersections of race and LGBTQIA+ identities. Using the principles of Cultural Humility, participants will critically examine how systems of care can offer a more affirming approach to service delivery for Queer and Trans community members, particularly those from BIPOC backgrounds. Recognizing that sexual orientation and gender are only two components of a person's identity, this session will take an intersectional approach to serving people as their whole selves.
