- Edits to notes in CG-I done after 12/31/23 will not be migrated. They must be recreated in CG-S manually.

## **Migrated Treatment Plans:**

- Plans created in CG-I from 10/25 -12/31/2023 will be migrated to CG-S
- (An earlier migration brought over plans created 7-1 to 10/24.)
- All the information, dates, and statuses, including approvals, will be retained
- The Plan ID numbers will be updated; the next highest number in the CG-SmartCare system will be substituted.
- Clinicians can look up the plans by the client's name or ID # to find the new Plan ID #.
- Revise the plans as usual when appropriate.

- Notes written by staff who have left an agency will be addressed later.
- We are working with management to develop the policy and procedures.
