

# Tackling Tobacco Together: A Deep Dive into Tobacco Treatment within Priority Populations

**Wednesday, July 23rd, 2024, 9:00 am – 12:30 pm PT**

**Description:** This training is part of a series that deep-dives into integrating local and state policy and tobacco use interventions into substance use disorder (SUD) and mental health treatment programs. Participants will first learn the basics of tobacco use disorder and the tobacco control policies that exist within Alameda County Behavioral Health (ACBH), along with AB541. They will then learn how to incorporate the required and recommended tobacco control policies into their programs in a trauma-informed and individually sensitive way. Participants will be instructed on the FDA-approved medications for tobacco use disorder, public resources for tobacco treatment, and how to create a recovery plan and helpful kits for clients.

**Who Should Attend:** This training is designed for administrative and/or clinical staff of Alameda County Public Health Department-contracted provider organizations and Alameda County Behavioral Health-contracted substance use treatment and mental health programs.

## Measurable Learning Objectives

- State the prevalence of tobacco use among at least two (2) behavioral health populations
- State at least two (2) methods for smoking cessation counseling
- Identify all seven (7) FDA approved pharmacological treatments for smoking cessation
- State at least one (1) workflow, systems and/or policy approaches to treating tobacco use
