Subject: **Fiscal Year 2025-26 OTP Rates**

ACBHD continues to provide communication updates regarding our system's Opioid Treatment Program (OTP) Rates. Effective July 1, 2025, in alignment with the most recent guidance from the California Department of Health Care Services (DHCS) for billing by CPT codes, ACBHD will be reimbursing the OTP programs utilizing the Fiscal Year (FY) 2025-26 Published OTP Rate Sheet (see Attachment A).

ACBHD completed a thorough analysis to establish the FY 2025-26 OTP rates and will continue to analyze systemwide finances and rates with community-based organization (CBO) providers including approved updates to these published rates as we move into subsequent FYs. The FY 2025-26 rates include the addition of group rates, aligned with changes to the DHCS published rates for Alameda County. This is based on an expectation of approximately 4.5 clients per group. Your OTP Contract Rate Sheet already include a footnote to ensure that updated ACBHD published rates, such as those in this communication, are automatically applied to your OTP contract without requiring a contract amendment.
