## Motivational Interviewing for Clients with Dual Diagnoses: Mental Health and SUDS

## **Course Objectives**

 Participants will be able to synthesize the spirit of Motivational Interviewing.

2.) Participants will identify 2 OARS skills to be used in the next 30 days.

3.) Participants will be able to recognize 3 differences between sustain talk, discord, and change talk.

4.) Participants will develop at least 3 new tools for practicing MI with clients with a dual diagnosis who are resistant to treatment.



This course will focus on the nuanced application of Motivational Interviewing fundamentals when working with clients dually diagnosed with a substance use and mental health disorder. Attendees will learn about the Fixing Reflex, the Spirit of Motivational Interviewing, the four processes, OARS (open-ended questions, affirmations, reflections, and summaries), the different forms of client communication (change talk, sustain talk, discord), and change plans. Attendees will practice the application of MI within the framework of harm reduction and trauma informed care. The workshop will include large group discussion, breakout groups, and practice with concrete MI exercises.
