#### **Course Description:**

Latinx communities have been historically discriminated against and marginalized within the United States. This has inherently created health and educational inequalities for Latinx populations when attempting to access mental health care. In an effort to combat these inequities and barriers to care with Latinx communities, we must examine our own axis's of power and privilege using anti-racism and intersectionality as a framework to engage in anti-racist and equitable care for Latinx and other communities of color. This workshop will engage participants: (1) Examining one's own axises of power and oppression (2) Reflecting on various forms of intersectionality that impact Latinx communities, and (3) Examine how this knowledge can be utilized to create more equitable mental health service delivery practices when working with Latinx populations.
