

# Creating a Smoke/Vape Free Agency

**Description:** This 1-hour training session will be focused on helping providers to establish tobacco and smoke-free environments within their facilities. Providers will understand the need to implement these policies. They will then gain the knowledge and skills needed to build successful programming to create a tobacco and smoke-free facility. Additionally, they will learn the proper steps and procedures to effectively implement functional program policies that meet the least amount of staff resistance.

**Who Should Attend:** This training is directed towards administrative and/or clinical staff of Alameda County Public Health Department providers and Alameda County Behavioral Health (ACBH) funded substance use treatment and mental health programs, but all staff are welcome to attend.
