## **Tobacco Treatment Specialist Supplemental Youth and Tobacco Module**

**Description:** This training focuses on special considerations for youth and tobacco. It is a supplemental module to the UMass Tobacco Treatment Specialist training. During this training, participants will gain an overview of factors that contribute to youth tobacco use, relevant statistics, preferred products and nicotine content, marketing by Big Tobacco specifically targeting youth, and common misperceptions. The training will also provide compelling information regarding stress and youth and trauma, youth, and tobacco. Additionally, participants will gain the knowledge and know-how to initiate conversations with youth regarding tobacco use, understand special considerations for treating youth for tobacco use disorder, and the best treatment practices to use.

Who Should Attend: This training is for participants of the September 2025 Tobacco Treatment Specialist Training hosted by LifeLong Medical Care in collaboration with University of Massachusetts Medical School.
