SUBJECT: Client and Service Information (CSI) Assessment Timeliness Reporting

The purpose of this memorandum is to announce the deployment of the CSI Timeliness Assessment screens in InSyst. These screens will replace the current CSI Assessment Record Data e-Form for data entry for SMHS providers. Fee For Service providers will continue using the e-Form.

Background

CSI Assessment Timeliness Data Reporting is required for new Medi-Cal and Medi-Cal eligible clients, those who are new to the mental health plan (MHP) and, returning clients who have not received outpatient services in the MHP system within the past 12 months.

With the exception of Out of County, Therapeutic Behavioral Services (TBS), Crisis, Conservatorship, Guidance Clinic and STAT programs, Alameda County SMHS providers have been submitting timeliness data using a CSI Assessment Record Data e-Form.

New CSI Timeliness Assessment Screens in InSyst

Effective immediately, the CSI Timeliness Assessment screens in InSyst will replace the CSI Assessment Record Data e-Form. These new screens allow for a simpler, more streamlined method for entering the information. Additionally, they include built-in validation to reduce data entry errors. Some of the data is pre-populated for ease of use and data can be entered partially if needed and completed at a later time.

In addition to internal testing, ACBH partnered with a number of providers to test these new screens. Two pilots were completed, resulting in very positive feedback and providers commenting that the new screens made it much easier to enter the needed data.

Action Required

Special access is required in order to use the new CSI Timeliness Assessment screens in InSyst. Please review the attached Onboarding Instructions document for access instructions as well as other important details and resources. Providers are asked to begin using these screens as soon as access is granted.
