SUBJECT: CalAIM Policies and Procedures Available—Documentation Redesign and No Wrong Door

This memorandum announces the availability of two new ACBH policies and procedures, in support of California Advancing and Innovating Medi-Cal (CalAIM) behavioral health initiatives: Documentation Redesign for Substance Use Disorder (SUD) & Specialty Mental Health Services (SMHS) and No Wrong Door for Mental Health Services. Both initiatives have a *July 1*, *2022* go-live date. Please note, both policies and procedures were developed by California Mental Health Services Authority (CalMHSA) and have been adopted by ACBH.

## **Background**

CalAIM is a California initiative led by the Department of Health Care Services (DHCS) that aims to provide broad delivery system, program, and payment reform across the Medi-Cal system. The goal of the initiative is to transform the Medi-Cal delivery system, moving it towards a population health approach that prioritizes prevention and whole person care. The vision is to "meet people where they are in life, address social drivers of health and break down the walls of health care."

Since December 2021, DHCS has published a number of Behavioral Health Information Notices, outlining specific changes to Medi-Cal requirements based on the CalAIM initiative. The following is an overview of the policy changes as well as the expected Go-Live dates for each.
