SUBJECT: Changes to Clinician Gateway (CG) to capture required screening of Individualized Determinations of

Need for Intensive Care Coordination (ICC), Intensive Home-Based Services (IHBS), and Therapeutic

Foster Care (TFC)

The purpose of this memorandum is to announce updates to County's Electronic Health Record, Clinician Gateway (CG) to capture required screening of the need for ICC, IHBS and TFC. This memo only applies to providers serving the children and young adult population under the age of 21.

## **Background**

DHCS released <u>Behavioral Health Information Notice No. 21-058</u> on September 17, 2021, reminding Mental Health Plans (MHPs) of their obligation to ensure that all children and youth under the age of 21 who meet medical necessity criteria be assessed and referred for ICC, IHBS and TFC. Per DHCS, membership in the Katie A. class or subclass and having an open child welfare services case is not a requirement for receiving medically necessary ICC, IHBS, or TFC. Effective March 7, 2022, individualized determinations of each child's/youth's need for ICC, IHBS, and TFC should be clearly documented in the child/youth's Specialty Mental Health Assessment for all new clients. For existing clients, this evaluation should be completed at the time of annual reassessment or sooner, if determined that the client is in need of these services. Please note: This requirement will not change as a result of the Cal-AIM initiatives.

On January 7, 2022, ACBH Quality Assurance (QA) Team issued a memo <u>Alameda County Behavioral Health (acbhcs.org)</u> reminding providers of this requirement and providing an optional checklist that could be used to document compliance with this requirement while awaiting updates to CG.

## **CG Updates**

Effective **April 1, 2022**, the Specialty Mental Health Assessment template in CG will be updated to include a section titled *Intensive Service Needs Assessment for ICC, IHBS, and TFC.* See below screenshot. Providers using CG should complete this template when assessing children and young adults under the age of 21.
