SUBJECT: **Clinicians Gateway (CG) SmartCare Note Changes Upcoming Demos**

This memorandum is being issued on behalf of ACBH Information Systems Support and announces updates to Clinician's Gateway to meet the requirements of CalAIM and the SmartCare billing system integration.

**Background**

Beginning July 1, 2023, the Department of Health Care Services (DHCS) California Advancing, and Innovating Medi-Cal (CalAIM) Payment Reform initiative will change the way county behavioral health plans claim federal reimbursement. The initiative consists of three different transitions: Reimbursement Structure, Financing Mechanism and Provider Billing.

Changes related to Provider Billing involve transitioning from the use of Healthcare Common Procedure Coding System (HCPC) codes to Current Procedural Terminology (CPT) Codes. Note: HCPC codes will continue to be used for non-clinical services and services provided by non-licensed staff.

Additionally on July 1, 2023, ACBH will transition from the current billing systems (InSyst and eCura) to SmartCare.

**Upcoming CG Demos**

To accommodate these transitions, some the CG fields were changed to align with the new SmartCare and CalAIM requirements and will go live on July 1, 2023.
