SUBJECT: Recorded Trainings and Live Virtual Meeting to Address Changes to FFS Outpatient

Therapy Level of Care

This memorandum shares important information for Fee for Service (FFS) outpatient therapy providers regarding upcoming changes to this level of care. Two recorded trainings are available and are to be viewed prior to the scheduled **December 8, 2022** Virtual Q&A Provider Meeting.

Background

Over the past several months the FFS Workgroup, consisting of ACBH staff from Quality Assurance (QA), Utilization Management (UM), ACCESS, Contracts, and Billing and Benefits Services (BBS), have worked to improve our FFS outpatient therapy level of care.

These changes were described in a <u>previous memo</u> to FFS providers sent out in May of this year. Some of the significant changes include ending the use of service packages and the Request for Continued Services form. In place of the service packages we will be using a Utilization Table that recommends the frequency of services within this level of care. Clients and Therapists will also be able to connect for treatment without a direct referral from ACCESS.

Overview of Resources and Events

We are excited to announce that we are nearly ready to operationalize these changes. In order to do so we have developed two recorded trainings that you can access via the ACBH Provider website and have scheduled a live virtual meeting for questions and answers.
